#### **MEMORANDUM HR11-2021**

Subject: Dependent Care Flexible Spending Accounts Extended Grace Period for

2021

Date: June 21, 2021

The Division of State Group Insurance provided the information below:

The <u>Consolidated Appropriations Act (CAA)</u> provided extended grace periods for Dependent Care Flexible Spending Accounts (DCFSA).

## For DCFSAs only:

- The grace period for the plan year ending on Dec. 31, 2020 was extended to allow more time to spend and submit claims for reimbursement of DCFSA funds.
  - Participants have until Dec. 31, 2021 to incur expenses using Plan Year 2020 dependent care FSA funds.
  - Participants must submit claims for expenses by the 2021 tax filing deadline.
- The plan year ending on Dec. 31, 2021 will have a grace period extension to allow for more time to spend and submit claims for reimbursement of DCFSA funds.
  - Participants have until Dec. 31, 2022 to incur expenses using Plan Year 2021 dependent care FSA funds.
  - Participants must submit claims for expenses by the 2022 tax filing deadline.

For example: An employee elected to contribute \$5,000 for Plan Year 2020, but incurred no dependent care expenses. The employee is permitted to use the \$5,000 of unused funds in Plan Year 2021. For Plan Year 2021, the employee elected to contribute \$10,500 to the plan. The employee may be reimbursed up to \$15,500 for eligible expenses during Plan Year 2021.

To access the Chard Snyder system, employees should either log in to the People First system and select the Chard Snyder quick link or use the Chard Snyder mobile application.
